SUMMARY OF THE PROCEEDINGS OF 33rd ANNUAL GENERAL MEETING

DATE, TIME AND VENUE OF THE MEETING

 The 33rd Annual General Meeting of the Company was held on Wednesday, 23rd September 2020 at 3.00 PM through Video Conferencing.

PROCEEDINGS IN BRIEF

- 2. Mr. Narendra Kr. Sureka, Chairman & Managing Director of the Company occupied the chair.
- 3. As per Section 103 of the Companies Act, 103 the required quorum for convening the AGM was present, accordingly the Chairman called the meeting in order.
- 4. The Chairman welcomed the Members to the 33rd AGM of the Company through Video Conferencing (VC). The Chairman introduced the Directors present and Round Call was taken. He informed that since the meeting was being conducted through VC there was no requirement for proxies. He further informed that the Register of Members, Register of Director's and Key Managerial Personnel and their shareholding, Register of Contracts, etc. were kept open for inspection by Members and the same were accessible in electronic mode to those shareholders who shall place request for the same.
- 5. With the consent of the Members present the notice of the 33rd AGM and the Auditor's Report were taken as read by the Chairman.
- 6. As per instruction from the Chairman, Mr. Archit Sureka, CFO read out the details of remote e-voting and instructions for AGM. He stated that in accordance with the provisions of the Companies Act, 2013, and the rules made thereunder, the remote e-voting facility for voting on the resolution(s) contained in the Notice of the 33rd AGM was provided to the Members of the Company from 9.00 am on 20th September 2020 and up to 5.00 pm on 22nd September, 2020 and that the e-voting module was closed by NSDL thereafter.
- 7. Four members had registered as speaker for the AGM. The queries raised by the Members at the meeting were suitably replied by the Chairman & Managing Director. The Chairman thereafter requested the Members who had not voted through remote e-voting to vote through the e-voting process provided at the AGM. Mrs. Gayatri Phatak, Practicing Company Secretary was appointed as Scrutinizer for scrutinizing the remote e-voting and e-voting at the AGM.
